



## Updates on Scoot Travel Advisories

Dear Trade Partners,

Scoot would like to draw your attention to our latest updates on travel advisories.

1. **Singapore Travel Advisory**

Singapore Citizen/ Permanent Resident Familial Ties Lane

Passengers can apply for a SafeTravel Pass under the Familial Ties Lane if they are an ICA-issued Long-term Visit Pass (LTVP) holder or a short-term visitor who is:

- An immediate family member or relative of a Singapore Citizen (SC) or a Singapore Permanent Resident (PR);
- A spouse-to-be of a Singapore Citizen or a Singapore PR;
- A PR and a LTVP In-Principle Approval holder seeking to complete formalities for long-term immigration facilities;
- A non-resident who has exceptional reasons for seeking entry into Singapore (i.e. death of a family member in Singapore)

Applications must be submitted at least 4 days prior to the passenger's intended date of entry into Singapore. Passengers who do not meet above requirements but need to enter Singapore due to extenuating circumstances, must seek approval from the [Immigration and Checkpoints Authority \(ICA\)](#).

Pre-departure COVID-19 Test (PDT)

All short-term visitors entering Singapore will need to take a pre-departure COVID-19 Polymerase Chain Reaction (PCR) test within 72 hours before their flight.

- Direct flights

- Passengers who take direct flight, the 72 hours will count from the flight departure to Singapore.
- Connecting flights
  - Passengers who take connecting flight(s) to Singapore, the 72 hours will count from the flight departure for first segment only and the total transit duration for the trip must not be more than 24 hours.
  - If the total transit duration exceeds 24 hours, a pre-departure COVID-19 test must be taken within 72 hours from the last segment (i.e. the flight to Singapore).

**2. Hong Kong Travel Advisory**  
 All passengers travelling to Hong Kong are required to submit a [health declaration form](#) within 2 days before their flight, and to download the 'LeaveHomeSafe' application on their mobile devices.

The Hong Kong government has boarding and compulsory quarantine requirements for passengers from different places. Passengers who have stayed in Brazil, Ireland, South Africa and the United Kingdom for more than 2 hours in the 21 days prior to departure date, will not be allowed to board flights for Hong Kong.

**3. Indonesia Travel Advisory**  
 Indonesia will temporarily close its borders to foreigners from 1 January 2021 to 8 February 2021. All passengers travelling to Indonesia are required to take a RT-PCR (Rapid Test-Polymerase Chain Reaction) within 48 hours before their flight.
