



# Travel Requirements Checklist

## Brunei Darussalam

Effective 15 June 2022

### ENTERING BRUNEI:



#### Vaccination Record

Fully vaccinated with 2 doses  
(Not required for travellers under 18 years old, certificate of medical exemption for unvaccinated travellers)



#### E-Health Arrival Declaration Form

Complete the form not more than 24 hours before departure to Brunei via [www.pmo.gov.bn/travelportal](http://www.pmo.gov.bn/travelportal) or [www.healthinfo.gov.bn/travel](http://www.healthinfo.gov.bn/travel)



#### Travel Medical Insurance

With COVID-19 coverage for foreign nationals only  
(For less than 90 days with minimum coverage of BND20,000)



#### Post-arrival COVID-19 test

(Only required for unvaccinated travellers)



#### Visa/Immigration Pass

(Applicable to nationalities requiring these documents for entry in Brunei)

### EXITING BRUNEI:



#### Vaccination Record

Fully vaccinated with 2 doses or received the booster dose for COVID-19 vaccine

For Bruneian citizens and residents aged 12 years and above

(Unvaccinated individuals must have certificate of medical exemption for COVID-19 vaccination)



#### E-register on Ministry of Foreign Affairs (MFA) website

Complete registration on [www.mfa.gov.bn/Pages/eRegister.aspx](http://www.mfa.gov.bn/Pages/eRegister.aspx)



#### Travel Medical Insurance

With COVID-19 coverage  
(Minimum coverage of BND\$20,000) for period of stay in foreign country



#### Next documents on-hand

Adhere to any other requirements set by the destination country

### TRANSITING IN BRUNEI:

For passengers continuing their journey after Brunei International Airport, please ensure you have the following:



#### Vaccination Record

Fully vaccinated with 2 doses



#### Next documents on-hand

Adhere to any other requirements set by the destination country

- Fully vaccinated travellers and travellers below 18 years old are not required to undergo post-arrival COVID-19 test and mandatory self-isolation.
- Pre-departure swab test for inbound travellers is no longer required, regardless of vaccination status.
