## Japan's "New Measures to Strengthen Border Control"

Please be advised that Japan's "New Measures to Strengthen Border Control Measures" is further revised and A negative certificate is not required if you have a valid three-dose vaccination certificate from 07th SEP 22.

### **≻** Visa Holder

\*Although the entry of new foreigners has been eased, it is still mandatory to obtain a visa for new arrivals.
Please pay attention to this.

## 1a. New entry of foreign nationals

Currently, foreign nationals/people who are willing to newly enter Japan need a visa newly issued by Embassies or Consulates or Consular Office of Japan with jurisdiction over the area in which the applicant lives or those with jurisdiction over the country of which the applicant's passport is issued depending on the purpose of their entry.

### 1b. Passengers for landing permission for VISA holder

- 1. Issued for Spouse or Child of Japanese National (Visa Category: (S) AS SPOUSE, CHILD OF JAPANESE)
- 2. Issued for Spouse or Child of Permanent Resident (Visa Category: (S) AS SPOUSE OF PERMANENT RESIDENT)
- 3. Issued for Diplomacy (Visa Category: (D) AS DIPLOMAT)
- 4. Date of issued after 02DEC2021 (including issued 02DEC2021) (Including all status, (Status "M27" issued from 01MAR2022 is also valid)

\*All VISAs issued before 101DEC2021 (1,2 and 3 are not included) have expired and must be renewed.

Passengers for landing permission for Resident Card Holder (all status) - (Need valid re-entry permit)

- Note-Airport change in Japan is not allowed (Ex/ DEL→HND→NRT→JFK) > Transit HND to NRT will continue to be prohibited for those who are travelling beyond as they require Japan documents to exit Japan airport.
- Note-Travelers with a connecting flight out of Narita International Airport the following day
